Collection Management

Acquisition of artifacts from Central NYS industries continued apace, including donation of a large collection of Ansco/GAF products and corporate records, PR documents from 20th century, and cameras, photosensitive material, and original images from Mercury, Gemini, and early Apollo missions. Inventors donated their collections- vintage video games from IBM Endicott game controller chip game controller chip design and prototypes/custom built infinite slope technology audio speakers (three pair) from Eastern Audio and one pair JosephAudio production model Pearl speakers.

Progress in restoring technological artifacts to operation included: IBM S/360 printer now supports full width souvenir banners, IBM 1401 system increased functions, with 1403 printer now able to play music. Work began on refurbishment of IBM 1255 check sorter. Apollo Mission Simulator components, on long-term restoration and display loan from the Smithsonian Institution, now have operable Star Balls and 3D collimated displays to illustrate Apollo-era display technology.

The large fraction of the collection in storage was moved to the second floor - 5,000 cu ft of shelving and 3,000 cu ft of artifacts.

Kicked off year with merit citations from Assemblywoman Lupardo and Broome County Executive Garnar to honor teams who earned the 2018 Tony Sale Award from Google UK and Computer Conservation Society UK for creating visitor experiences for 3 generations of Link Pilot Trainers - WWI geared computer (WWII), solid state technology (1960s), equations of motion built into software (1990s). Training sessions of Code Your Own Video Games were offered with and for students at Binghamton University (BU), BOCES, and Binghamton High School. Co-hosted 2019 Global Game Jam at SUNY Broome Community College. Hosted TechWorks! visits for the 6th grade at East & West Middle Schools. SUNY Broome & BU students joined in class visits, lectures, & 2,500 hrs of for-credit work in Computer Science, Marketing Strategy, and Watson School of Engineering, plus 1,800+ hrs of community service by BU and Binghamton HS PALS teams.

50th anniversary events of Apollo 10 with NASA guest lecturer/tour & Apollo 11 - Family Fun Day filled the house at TechWorks!

Hosted annual TechWorks! events - Binghamton Bridge Pedal, Baby It's CODE Inside day, Roots of Simulation reception.

Tech displays at NorthEast Astronomy Forum (NEAF 2019), Seton HS STEM Fair, & Lockheed Martin Science Fair (plus speech).

Progress towards rehabbing TechWorks! Central Block includes building permits, construction RFP/bids, and preparing space for work by moving collection storage to 2nd floor. Preliminary planning for Out of This World Technology gallery to be installed under the new Central Block Roof began in earnest.
